By completing this registration form and submitting a registration fee of \$100, I am expressing my intention to take the February 2017 Multistate Performance Test (MPT) and the Multistate Essay Exam (MEE) portions of the Minnesota State Bar Examination on computer using the blocking software SofTest™.
2. My choice to use a laptop computer and the SofTest™ software is completely voluntary.
3. I may elect at any time before or during the examination to handwrite the examination. No refund of the SofTest™ registration fee will be made within 15 days of the first day of the exam for which I have registered.
4. I understand and agree to the following:
 - a. I will either keep this email account active or, in the event I change email accounts, I will promptly report to the Board my new email address.¹
 - b. I agree to locate internet access and upload my answers by **9 P.M. on Wednesday, February 22, 2017.**
 - c. I agree that if I fail to upload my answers by **9 P.M. on Wednesday, February 22, 2017,** my MPT and MEE answers may NOT be graded and I may fail the Minnesota Bar Examination.
 - d. The use of SofTest™ in taking the MPT and MEE portions of the Minnesota Bar Examination carries with it some risks, including but not limited to i) power failure, ii) computer failure, iii) software failure, iv) problems uploading answers, v) loss of examination answers, vi) inability of the Board of Law Examiners to download electronic answers, and vii) other risks associated with using electronic technology to write examination answers.
 - e. If it becomes impossible to begin or complete writing the MPT and MEE answers on computer, I will hand-write answers to questions.
 - f. Under no circumstances will I be given extra time or other concessions in order to write or submit my answers.
 - g. My laptop **SHALL** remain in the examination room for the entire length of the MPT and MEE portions of the exam, including in the event that I am obliged to hand-write any portion of the examination.
 - h. If I remove my laptop from the examination room for any reason or violate the rules of the exam, I will be disqualified immediately and my exam answers will not be graded.
5. I agree to hold harmless the State of Minnesota, the Minnesota Board of Law Examiners, its agents, employees and assigns, from any liability relating to my voluntary use of SofTest™ to answer questions on the Minnesota Bar Examination.
