- By completing this registration form and submitting a registration fee of \$100, I am expressing my intention to take the July 2022 Multistate Performance Test (MPT) and the Multistate Essay Exam (MEE) portions of the Minnesota State Bar Examination on computer using the secure testing software ILG Exam360<sup>®</sup>.
- My choice to use a laptop computer and the ILG Exam360<sup>®</sup> software is completely voluntary.
- I may elect at any time before or during the examination to handwrite the examination. No refund of the ILG Exam360<sup>®</sup> registration fee will be made within 15 days of the first day of the exam for which I have registered.
- I understand and agree to the following:
  - I will be required to install the ILG Exam360<sup>®</sup> software on my laptop and, when in use, the software will restrict or prohibit various functions, access, and capabilities of my laptop.
  - I will either keep the above email account active or, in the event I change email accounts, I will promptly report to the Board my new email address.<sup>1</sup>
  - I agree to locate internet access and upload my answers by **9 P.M. on Wednesday, July 27, 2022.**
  - I agree that if I fail to upload my answers by **9 P.M. on Wednesday, July 27, 2022**, my MPT and MEE answers may NOT be graded and I may fail the Minnesota Bar Examination.
  - The use of ILG Exam360<sup>®</sup> in taking the MPT and MEE portions of the Minnesota Bar Examination carries with it some risks, including but not limited to i) power failure, ii) computer failure, iii) software failure, iv) problems uploading answers, v) loss of examination answers or other data loss, vi) inability of the Board of Law Examiners to download electronic answers, vii) other risks associated with using electronic technology to write examination answers, and viii) data security risks associated with transmitting my name, contact information, and essay answers to ILG Technologies via the Internet and storing such information on hosted servers, even if conducted via secure methods.

  - My laptop **SHALL** remain in the examination room for the entire length of the MPT and MEE portions of the exam, including in the event that I am obliged to handwrite any portion of the examination.
  - If I remove my laptop from the examination room for any reason or violate the rules of the exam, I will be disqualified immediately and my exam answers will not be graded.
